**BUDGET AND APPROPRIATION ORDINANCE  
DUNDEE TOWNSHIP OPEN SPACE BOND  
DEBT REPAYMENT FUND  
ORDINANCE #2017-3**

An ordinance appropriating for all Town purposes for Dundee Township, Kane County, Illinois, for the fiscal year beginning MARCH 1, 2017 and ending FEBRUARY 28, 2018.

BE IT ORDAINED by the Board of Trustees of Dundee Township, Kane County, Illinois.

SECTION 1: That the amounts hereinafter set forth, or so much thereof as may be authorized by law, and as may be needed or deemed necessary to defray all expenses and liabilities of Dundee Township be and the same are hereby appropriated for the Open Space Bond Debt Repayment purposes of Dundee Township, Kane County, Illinois, as hereinafter specified for the fiscal year beginning MARCH 1, 2017 and ending FEBRUARY 28, 2018.

SECTION 2: That the following budget containing an estimate of revenues and expenditures is hereby adopted for the following funds,

**OPEN SPACE BOND DEBT REPAYMENT FUND**

SECTION 3: That the amount appropriated for town purposes for the fiscal year beginning MARCH 1, 2017 and ending FEBRUARY 28, 2018 by fund shall be as follows:

SECTION 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional such decision shall not affect the validity of the remaining portion of this ordinance.

SECTION 5: That each appropriated fund total shall be divided among the several objects and purposes specified, and in particular amounts stated for each fund respectively in Section 2 constituting the total appropriations in the amounts of **One Million Nine Hundred Twenty Six Thousand Seven Hundred Two and no/100 Dollars (\$1,926,702.00)** for the fiscal year beginning MARCH 1, 2017 and ending FEBRUARY 28, 2018.


SECTION 7: That a certified copy of the Budget & Appropriation Ordinance must be filed with the County Clerk within 30 days after adoption.
