Section 5: That each appropriated fund total shall be divided among the several objects and purposes specified, and in the particular amounts stated for each fund respectively in Section 2, constituting the total appropriations in the amount of **Two Million One Hundred Sixteen Thousand Five Hundred and Seventy Seven and no/100 Dollars** (\$2,116,557.00) for the fiscal year beginning MARCH 1, 2012 and ending FEBRUARY 28, 2013.

Section 6: That Section 3 shall be and is a summary of the Annual Appropriations Ordinance of this Township, passed by the Board of Trustees as required by law and shall be in full force and effect from and after this date.

Section 7: That a certified copy of the Budget & Appropriation Ordinance shall be filed with the County Clerk within 30 days after adoption.
