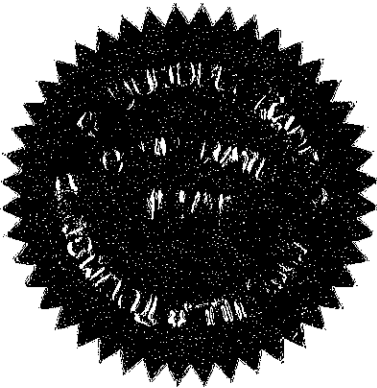



An Ordinance levying taxes for all town purposes for Dundee Township, Kane County, Illinois, for the **tax year 2016 collectable in 2017**.

BE IT ORDAINED by the Board of Trustees of Dundee Township, Kane County, Illinois, as follows:

SECTION 1: That the sum of **Three Million One Hundred Six Thousand Six Hundred Seventy and no/100 Dollars (\$3,106,670)** are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as: **General Town Fund, Open Space Bond Fund and General Assistance Fund** for the **tax year 2016, collectable in 2017**.

SECTION 2: That the amount levied for each object and purpose shall be as follows:




SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.
