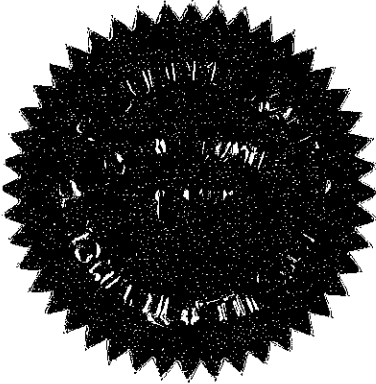



**DUNDEE TOWNSHIP ROAD DISTRICT TAX LEVY
RESOLUTION 2016-013**

An ordinance levying taxes for all road purposes for Dundee Township Road District, Kane County, Illinois, **for the tax year 2016, collectable in 2017.**

BE IT ORDAINED by the Board of Trustees of Dundee Township Kane County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Dundee Township Road District on December 16, 2015 does hereby determine and declare that the sum of **One Million Six Hundred Fifty Seven Thousand Seven Hundred Eighty Five and no/100 Dollars (\$1,657,785)** are hereby levied upon all property subject to taxation within the Road District as property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as: **General Road and Bridge Fund, Road and Bridge Insurance Fund, Road and Bridge IMRF Fund, Road and Bridge Social Security Fund, and Road and Bridge Building and Equipment Fund** for the tax year 2016, collectable in 2017.

Section 2: that the amount levied for each object and purpose shall be as follows:

RESOLUTION 2016-013**

SECTION 3: That the Town Clerk shall file with the County Clerk of said County of Kane, on or before the last Tuesday of December, a duly certified copy of this ordinance.

SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for Dundee Township Road District.

SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not effect the validity of the remaining portion of this ordinance.


SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.
