**BUDGET AND APPROPRIATION
ORDINANCE DUNDEE TOWNSHIP ROAD
DISTRICT ORDINANCE #2016 -3**

An ordinance appropriating for all road purposes for Dundee Township Road District, Kane County, Illinois, for the fiscal year beginning MARCH 1, 2016 and ending FEBRUARY 28, 2017.

BE IT ORDAINED by the Board of Trustees of Dundee Township, Kane County, Illinois.

SECTION 1: That the amounts hereinafter set forth, or so much thereof as may be authorized by law, and as may be needed or deemed necessary to defray all expenses and liabilities of Dundee Township Road District, be and the same are hereby appropriated for road purposes of Dundee Township Road District, Kane County, Illinois, as hereinafter specified for the fiscal year beginning MARCH 1, 2016 and ending FEBRUARY 28, 2017.

SECTION 2: That the following budget containing an estimate of revenues and expenditures is hereby adopted for the following funds,

**Road and Bridge General Fund
Road and Bridge IMRF/FICA Fund
Road and Bridge Insurance Fund
Road and Bridge Building and Equipment Fund**

SECTION 3: That the amount appropriated for road purposes for the fiscal year beginning MARCH 1, 2016 and ending FEBRUARY 28, 2017 by fund shall be as follows:

GENERAL FUND	\$747,665
BUILDING & EQUIPMENT FUND	\$117,892
IMRF/FICA FUND	\$65,850
INSURANCE FUND	\$38,600
TOTAL APPROPRIATIONS:	\$970,007

SECTION 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional such decision shall not affect the validity of the remaining portion of this ordinance.

SECTION 5: That each appropriated fund total shall be divided among the several objects and purposes specified, and in particular amounts stated for each fund respectively in Section 2 constituting the total appropriations in the amounts of **Nine Hundred Seventy Thousand Seven and no/100 Dollars (\$970,007.00)** for the fiscal year beginning MARCH 1, 2016 and ending FEBRUARY 28, 2017.

SECTION 6: That section 3 shall be and is a summary of the Annual Appropriation Ordinance of this Road District, passed by the Board of Trustees as required by law and shall be in full force and effect from and after this date.


SECTION 7: That a certified copy of the Budget & Appropriation Ordinance must be filed with the County Clerk within 30 days after adoption.
