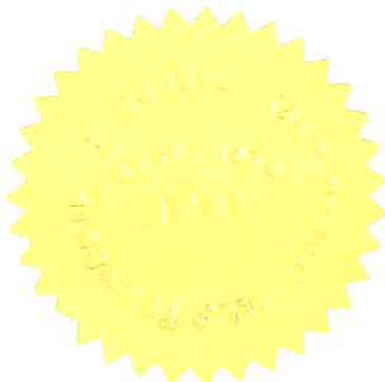

**DUNDEE TOWNSHIP TAX LEVY
ORDINANCE 2018-007**

An Ordinance levying taxes for all town purposes for Dundee Township, Kane County, Illinois, for the **tax year 2018 collectable in 2019.**

BE IT ORDAINED by the Board of Trustees of Dundee Township, Kane County, Illinois, as follows:

SECTION 1: That the sum of **One Million Three Hundred Seventy Two Thousand Four Hundred Forty Seven and no/100 Dollars (\$1,372,447)** are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as: **General Town Fund and General Assistance Fund for the tax year 2018, collectable in 2019.**

SECTION 2: That the amount levied for each object and purpose shall be as follows:
